REGULATIONS APPENDIX #1

1 - ALCOHOL AND DRUGS

The use of Alcohol and/or Drugs are strictly **<u>FORBIDDEN</u>** on the firing line. Any member or guest who shows signs of impairment will be refused range privileges by the Range Officer. Violations of this rule shall result in loss of range privileges and suspension from the club.

2 - <u>RANGE OFFICER</u>

A Range Officer will be named and will be present each and every time the range is in use. An individual member when using the range alone will act as the Range Officer. The Range Officer will have absolute authority over all range activities. Any member in good standing over 18 (eighteen) years of age may be asked at any time to assist as a Range Officer.

3 – <u>FIREARMS</u>

- a) All firearms must be approved by the Range Officer before being used on the range (i.e. general condition, proper ammunition, etc.).
- b) Shotguns up to and including 10 gauge may be used. Shot no larger than number 7 ½ may be used for aerial targets.
- c) Center fire rifles up to and including .46 caliber may be used.
- d) Black powder shotguns up to and including 10 gauge may be used.
- e) Black powder rifles up to and including .75 caliber may be used.
- f) Rim fire, center fire, and black powder handguns may also be used.
- g) Maximum number of rounds to be loaded in the magazine will be decided by the Range Officer, according to the type of competition.

4 – RANGE IN USE

A sign in both official languages will be posted at the entrance to the range at all times when the range is in use. A red warning flag will be flown at all times when the range is in use.

5 – <u>AGE LIMITS</u>

a) The minimum age of any person shooting on the range will be ten (10) years old. Any person between the ages of ten (10) and eighteen (18) years of age may participate in shooting activities only when under the direct supervision of a club member, who will act in cooperation with the Range Officer.

b) Any family member (excluding your spouse) reaching the age of eighteen (18) must hold their own membership.

6 – <u>TARGETS</u>

Targets may be supplied by the member or by the club when available. Only targets which have been approved by the club may be used on the range. Paper, cardboard, plastic or other soft material that will not fragment or cause bullets to ricochet dangerously may be used as center fire rifle targets when placed on or below designated target stands. Placement of clays on the backstop or on the berm in front of the target line is not an approved practice because of the possibility of a ricochet over the top. Members and guests are responsible for removing used targets and any refuse from the range before they leave. The use of foam cans, kitchen appliances, glass bottles, and fruits or vegetables as targets are NOT permitted.

7 – <u>SPENT AMMO</u>

All spent ammo cartridges are to be picked up and placed in the appropriate containers and sorted by "Brass", "Aluminum", and "Steel". The club provides hand magnets to assist in the picking up of steel cased cartridges. Shotgun shells, if you are not reloading them, are considered to be garbage and should be placed in the garbage bags provided at the firing lines. The only exception to this is for .22 Long Rifle casings which are too small and difficult to pick up.

8 – <u>USED TARGETS</u>

Used paper targets, cardboard targets, cardboard cartridge boxes, and coffee cups are considered to be burnable and are to be placed in the burn barrels provided. Do not put them in the garbage bags.

9 – <u>MEMBER PRIVILEGES</u>

Members, their spouses and all children are entitled to all range privileges under one membership. Any member found to be lending their key to the range to unauthorized personnel will forfeit their membership for life.

10 – <u>GUESTS</u>

Guests may use the range under the following conditions:

- a) That they be accompanied by a club member.
- b) That their name be printed into the log book, that they print and sign their name on the liability waiver form and have it witnessed and signed by the club member who will then put the form in the appropriate container. Guests must complete the waiver every time they visit the range.

- c) That they follow the directions of the Range Officer.
- d) That there be no more than two (2) guests per member at any one time.
- e) Guests who have been to the range on two (2) previous separate occasions are expected to become members. It is not our intent to create permanent guests.

11 – <u>SIGNING IN</u>

All members and their guests must sign in and out showing their arrival and departure times in a log book provided in the seacan - PRINT LEGIBLY. Members are encouraged to note any unusual conditions seen when arriving at the range. Enter information in the log book with the time noted. Serious conditions should be phoned in to a member of the club Executive as soon as possible.

12 - <u>RESTRICTIONS</u>

Any person who is prohibited by law from possessing firearms will be refused membership in the club. Any member who loses his privilege to possess firearms will be suspended for the period of such prohibition.

13 – <u>APPEALS</u>

Any member penalized for a violation of club regulations may appeal his / her penalty before an appeals panel appointed by the club executive. The request for appeal must be made in writing to the President within thirty (30) days of becoming aware of the penalty. The appeal panel will hear the appeal within sixty (60) days of the request for appeal being filed with the President.

14 - ADDENDA TO REGULATIONS - APPENDIX #1

Any member while acting in the capacity of Range Officer, who knowingly permits any member or guest to use the club range while using or appearing to have been using alcohol and/or non-prescription drugs, will be subject to suspension and/or dismissal from the club. Any charges or violations of this rule shall be heard at the next meeting following any such violation. The Executive will set the penalty, with the President's ruling being final.
