You must be 16 years of age to shoot and you must complete a Liability Waiver  
Disclaimer: You don't need a firearms license to attend, however, **it is a federal offense for anyone that is “under a court-ordered prohibition from possessing firearms” to be at a shooting range.** Please note that photo, video, and audio recording may be done at the event and used by Fundy Shooting Sports Inc.

Eye and hearing protection will be provided. We encourage that the neck/cleavage areas be covered in case of a stray hot shell casing. A ball cap is recommended for everyone to protect your face. Sandals, flip flops or heels are **not acceptable** footwear for the range, enclosed toe shoes/sneakers are recommended for your safety.

# Firearm Pictures and information!

**.22LR Pistol:** Semi-automatic handgun that fires a smaller round. It has very little recoil and makes it easier to learn what a handgun feels like.



**9mm Pistol:** Semi-automatic handgun with the most standard round. It has manageable recoil and gives you the real sensation of a handgun. For reference, 9mm is what law enforcement carry and use.



**.22LR Rifle:** Semi-automatic rifle that fires a smaller round. It has very little recoil and makes it easier to learn what a rifle feels like.



**9mm Rifle:** Semi-automatic rifle that fires a 9mm round. It has little recoil compared to the standard rifle rounds but functions the exact same as rifles used for sport shooting like the AR-15.



**12GA and 20GA Shotgun:** Pump Action shotguns with 2 available rounds.  
The 12GA is your standard shotgun round with a little more kick. The  
20GA offers a smaller round with less recoil.

## BASIC HANDGUN USE & SAFE PRACTICES

**#1 Treat all guns as if they are always loaded.**

**#2 Never point a gun at anything that you don't want to destroy.**

**#3 Keep your finger off the trigger until your sights are on target and you have made the decision to shoot.**

**#4 Be sure of your target and what lies beyond it.**


### GRIP:




- Place the gun securely into your dominant hand. Spread apart your thumb and index finger. Place the gun into the crook that forms, keeping the gun back strap as high as possible.
- Wrap your middle, ring, and pinky fingers around the grip of the pistol. Your middle finger should rest just below the trigger guard.
- For the time being, rest your index finger along the opposite side of the gun frame.
- Wrap your thumb around the grip. It should touch the top side of your middle finger from the other side.
- Notice that there is a gap between the heel of your hand and the tip of your fingers to the left side of the grip. Take your non-dominant or support hand and wrap it around the strong hand so that this gap is no longer visible.
- Position the thumb of your non-dominant hand so that it overlaps with the thumb of your dominant hand.
- When it comes time to fire the gun, place your index finger on the trigger. The space between the tip of your finger and the top knuckle should be the only part on the trigger.

### Proper Sight Pictures: FOCUS ON THE FRONT SIGHT!

**When sighting your target the FRONT sight should be in FOCUS, the rear sight & target will appear slightly blurry – this is normal!**

**A. ACKNOWLEDGE AND AFFIRM:**

1. That I have read the Safety Rules of FSSI as posted.
2. I am aware that shooting sports and all activities related thereto involve inherent risks, dangers and hazards, including the risk of serious personal injury or death.
3. I freely accept and fully assume all risks, dangers and hazards and the possibility of personal injury, death, property damage or loss resulting from my participation in shooting activities.
4. I hereby release FSSI from any and all liability for any loss, damage, injury or expense that I, or my next of kin, may suffer or incur as a result of my actions at the shooting range.
5. I hereby acknowledge that I am not under any prohibition from handling, possessing, or using firearms and/or ammunition and/or prohibited devices of any nature (in other words, ask yourself if the police or a probation officer would be upset that you were here).
6. I further acknowledge and agree that if at any time, I believe the conditions to be unsafe and/or the conditions are objectively unsafe on the premises or in relation to the conduct of any person present, I will immediately discontinue further participation in the shooting sport or activity and immediately notify the FSSI representative.

**B. WAIVER AND RELEASE:** Fundy Shooting Sports Inc. **Be aware that during any instructional demonstration that there may be some physical touching in order to show the proper firearm holding and standing positions.**

**Firearm Safety:**

You will see firearm safety reminders posted throughout our facility, not just in the range area. All staff, members and users of this range must follow these rules at all times. They are clear and simple, and if they are never violated, a firearm can never without human intervention accidentally harm anybody.

- ASSUME EVERY FIREARM IS LOADED**
- CONTROL THE MUZZLE DIRECTION AT ALL TIMES**
- KEEP YOUR FINGER OFF THE TRIGGER AND OUT OF THE TRIGGER GUARD UNTIL YOUR SIGHTS ARE ON THE TARGET**
- ALWAYS BE SURE OF YOUR TARGET AND BEYOND**

**Range Safety:**

- Everyone must wear ear and eye protection while in the shooting bays
  - Firearms will only be loaded on the firing line.
  - Keep your muzzle pointed below the top of the range backstop.
  - Nobody will move in front of the firing line for any reason, without the approval of a Range Officer.
  - Only ammunition of the types and calibers authorized will be used. When in doubt ask the staff.
  - Remember that lead is a hazardous material and that while shooting you can be exposed to it.
- For your own safety, do not eat or drink on the ranges after you have been shooting without first washing your hands. Remember to wash your hands before leaving the facility and/or before eating or drinking.
